I. Young Professional-I (02 Posts):

Emoluments	:	Rs.25,000/- per month (Consolidated)
Essential Qualification	:	BFSc/ MSc. In Chemistry/ Food Science and Technology/ Food Science/ Food Engineering.
Desirable Experience	:	Experience in testing of chemical residues, heavy metals using mass spectrometry-based methods.
Age limit	:	Candidates should be above 21 years and maximum of 45 years as on date of interview. Age relaxation as per rules.

2. Age relaxation of 3 years for OBC candidates and 5 years for SC/ST candidates is permissible.
3. Candidate should possess 1st class or 60% marks or equivalent overall GPA

Candidates are required to submit detailed bio-data (in the enclosed format) affixing a recent passport size photograph alongwith attested copies of all the Certificates in support of their claims regarding age, educational qualifications, Scheduled Caste/ Scheduled Tribe/OBC etc. **The original certificates shall be produced for verification before the interview.**
5. **The candidate should at least hold a Provisional Certificate in r/o. Graduation/ Professional Courses. (website results/ result awaiting candidates will not be considered)**
6. The selected candidate will be recruited on contract basis under ICAR norms. The post is purely temporary.
7. The candidate attending the interview should ensure that they fulfill all the eligibility conditions. No correspondence will be entertained from the candidates for selection/test/appointment
