The age limits will be reckoned as on 01-01-2023. The candidate should note that the date of birth as recorded in the Matriculation/SSC or equivalent certificate will only be accepted as proof of age. The upper age limit is relaxed as under for different categories as per Government of India's instructions:

- (a) GENERAL/OBC Candidates : 5 years  
(b) SC/ST Candidates : 10 years
