### **RECRUITMENT RULES OF SENIOR EXECUTIVE TRAINEE (Direct Recruitment)-2024 in BSNL**

**No. BSNLCO-PERS/15(17)/2/2023-PERS1**

**Dated: 26.02.2024**

#### **1. Short Title and commencement:**

With the approval of BSNL Board and in supersession of the BSNL Management Trainees Recruitment Rules-2013 and subsequent amendments/modifications thereof, the following rules regulating the method of recruitment to the post of Senior Executive Trainee-Direct Recruitment [SET(DR)]-2024 in Bharat Sanchar Nigam Limited (BSNL) are hereby made:

- (i) These rules may be called as **Senior Executive Trainee (Direct Recruitment) Recruitment Rules-2024**.
- (ii) These rules shall come into force from the date of notification.
- (iii) Powers for relaxation/modification/amendment to these rules will vest with the BSNL Board.

#### **2. Definition: In these Rules unless the context otherwise requires,**

- (i) **Company:** Means Bharat Sanchar Nigam Limited (A Government of India Enterprise) hereinafter called BSNL, having its Registered Office at Bharat Sanchar Bhawan, Janpath, New Delhi.
- (ii) **Board:** Means the Board of Directors of the Company and includes in relation to the exercise of powers by any Committee of the Board/Management or any other Officer of the Undertaking to whom the Board delegates its powers.
- (iii) **Functional Stream:** Means the discipline to which the Executive has to be recruited, viz. Telecom Operations, Finance, Civil and Electrical.

#### **3. Application: These Rules shall apply to the post as specified in Column (1) of the Schedule annexed to these Rules.**

**4. Appointing Authority:** Appointing Authority will be Director (HR), BSNL Board, Bharat Sanchar Nigam Limited.

**5. Number of posts, Classification and Scale of pay:** Senior Executive Trainee (DR) shall be recruited in IDA pay scale of Rs. 24,900-50,500/- (E-3) against AGM(External Quota) posts. The requirement of SET(DR) shall be worked out before each recruitment process based on the actual need of the company. Further, for every recruitment process, the breakup of various Functional Streams shall be decided by the Company from time to time. Maximum number of posts of Senior Executive Trainee (DR) to be used for recruitment at E-3 level and for promotion to the AGM Grade in E-4 pay scale in each Functional Stream, as given in the Recruitment Rules of BSNL Management Services-2023 of the respective Stream are as under:

**6. Method of Recruitment, age limit, qualifications, probation etc.:** The method of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in Column 5 to 13 of the Schedule annexed.

**7. Bond, Training and Probation:** All candidates recruited for the post of Senior Executive Trainee (DR) shall execute a Bond in the format as specified by the Company to serve in BSNL for a period of **five years** from the date of their appointment as Senior Executive Trainee or for a period as specified by BSNL for the post, from time to time. The Bond amount will be of Rs. 8 lakhs for calendar year(s) 2024 and 2025 and for the calendar year(s) 2026 and 2027, the same will be of Rs. 9 lakhs. Thereafter, this limit shall be reviewed.

All Senior Executive Trainee (DR) will remain on probation for two years running concurrently with training schedule of 52 weeks [One Year] including examinations during training as per details given below:

7.1 Common Managerial Training – Total 13 Weeks

7.2 Training related to functional Stream – 13 Weeks

7.3 On Job Training – 26 weeks

7.4 If the candidate fails to successfully complete the training including the examination during training, then his/her probation shall be extended by 6 months, followed by Examination. He/ She will be placed below in seniority than the candidates who have already cleared the exam.

7.5 On failure in successful completion of training including examinations during the period of training even in extended period, his/her appointment/selection to BSNL shall be treated as cancelled.

**8. Career Progression:**

After successful completion of probation, SET(DR) shall be designated as Senior Executive (DR) in E-3 pay scale. On working as Senior Executive(DR) for further one year i.e. minimum 3 years of service from their date of appointment as SET(DR), shall be considered for promotion as Assistant General Manager (E-4 Pay scale) of the respective Stream (against the post of AGM as given in clause 5 above) as per provisions of Recruitment Rules of BSNL Management Services-2023 of the respective Stream.

Further career progression for promotion to higher grades shall be regulated by BSNL MSRRs-2023 of the respective Stream.

**9. Seniority:** Seniority of candidates selected and appointed as Senior Executive Trainee(DR) of respective Stream will be as per final merit list to be prepared on the basis of marks obtained in the prescribed selection process. Further, on their promotion to AGM grade, their inter-se-seniority in the AGM grade and higher grades shall be regulated in accordance with the provisions of Recruitment Rules of BSNL Management Services-2023 of the respective Stream.

**10. Disqualification:** No Person,

a) Who has entered into or contracted a marriage with a person having a spouse living,

or

b) Who having a spouse living, has entered into or contracted marriage with any person,

shall be eligible for appointment to the said post.


Provided that the Appointing Authority may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

**11. Saving:** Nothing in these rules shall affect reservations, relaxation of age limit and other concession required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward Classes, PwBDs, and other special category of persons in accordance with the orders issued by the Central Government from time to time in this regard.

**12. Liability to serve anywhere in India:-** Persons appointed to the Senior Executive Trainee(DR) post shall be liable for transfer anywhere in India/ at any place falling in the operational area of BSNL.

**13. Residuary matters:** In regard to matters not specifically covered by or under these Rules, the persons appointed will be governed by the rules, regulations and orders decided upon by the Company.

**14. Interpretation:-** Where any doubt arises as to the interpretation of any of the provisions of any of these rules or the regulations made there under, the matter shall be referred to BSNL Board whose decision shall be final.


