

For the purpose of importing 20,000 m.t of thermal coal through port Monidip the importer X had chartered a ship. After careful gathering of relevant data he could assess that

- i) The vessel would discharge his cargo at the working berth @ 2000 m.t per day. However, the discharge rate would reach at the level of 2500 m.t per day if a pay loader can be engaged on shore to work simultaneously. For that pay loader operator will charge him Rs 1000/- per day.

The average hook cycle time for both the crane is 30 seconds. But the same goes up to 40 seconds when both the cranes are made to work together in the same hatch. Crane requires to travel 10 minutes on shore in order to reach next nearest hatch from the preceding one.

You are required to choose appropriate plan of work for the cranes to work on the ship and complete the work at the earliest possible time from the following options:

- i) Engage one crane (K1) to complete work serially from Hatch-1 to Hatch-2 and so on moving towards the aft of the ship. At the same time engage crane (K2) at Hatch-5 to complete the hatch and then move towards Hatch-4 and so on towards the forehead of the ship.
- ii) Engage both the cranes simultaneously at Hath-4. After finishing the work together there K-1 would move towards the forehead of the ship and complete the works in the Hatches falling on its way, while K2 will go to Hatch-5 to finish the work.
- iii) Engage both the cranes simultaneously at Hatch-4 and after some time, before finishing the work there, K-1 would move towards the forehead of the ship and complete the works in the Hatches falling on its way, while K2 will go to Hatch-5 after finishing the balance work at Hatch-4.

K1 simultaneously at Hatch-5 and K1 simultaneously at Hatch-4. After some time, before finishing the work there, K-1 would move towards the forehead of the ship and complete the works in the Hatches falling on its way, while K2, after finishing the work at Hatch-5 will go to Hatch-4 to complete the balance works thereat left over by K1.
